## 1. Registration

**According to Title II of the Regulation (EC) No 1907/2006 of the European Parliament and of the Council (REACH)**

SYNTHOS PS polystyrenes (trade names: SYNTHOS PS GP 525, SYNTHOS PS GP 535, SYNTHOS PS GP 585 A, SYNTHOS PS GP 585 C, SYNTHOS PS GP 585 X, SYNTHOS PS GP 137, SYNTHOS PS GP 152, SYNTHOS PS GP 154, SYNTHOS PS GP 171, SYNTHOS PS GP 172, SYNTHOS PS GP 174, SYNTHOS PS GP 174 H, SYNTHOS PS GP MG 130M, SYNTHOS PS GP MG 170M, SYNTHOS PS GP MG 171M, SYNTHOS PS HI 336M, SYNTHOS PS HI 552M, SYNTHOS PS HI 562E, SYNTHOS PS HI 662E, SYNTHOS PS HI 945 E) are mixtures composed of styrene homopolymer or styrene-butadiene copolymer and additives. According to art. 2(9) of the Regulation (EC) No 1907/2006 of the European Parliament and of the Council (REACH) the products are exempted from registration.

The monomers are subjected to registration according to Art 6(3), if their content in the polymer is at least 2% wt. According to our best knowledge all raw materials used for production of SYNTHOS PS have been either registered or are exempted from registration.

The registration numbers of a monomer and additive are listed in the table below.
